MINOR) **DECLARES and RECOGNIZES** for itself and for any eventuality or right, the following in respect of Turismo Lavarone Srl, headquartered in Fr. Gionghi 107, Lavarone (TN), as the operator for the ski-lift and the Bike Park Lavarone trails:

1. Being aware that the discipline of DownHill, Freeride and Enduro involves certain risks and therefore the trails are posted with the degree of difficulty and they should be selected according to the rider capabilities. A beginner should be followed by an experienced companion;
2. To have read the rules, limitations and prohibitions posted at the departure point, the ticket booth and along the paths and to follow them strictly; to declare to know all the sporting regulations for the equipment in use, the facilities and the rules governing the use of the trails that you plan to go on;
3. To be in good physical and psychological health and that your visual and motor skills are compatible with the use of trails and transport systems of the Bike Park Lavarone;
4. To use the equipment exclusively where permitted by laws and regulations and to assume responsibility for using it;
5. To exempt from any liability in the broadest way for themselves and for their successors and assigns for any reason the operator company and its directors and waive any claim for damages by way of compensation, reimbursement or compensation for damages in the event of injury occurred to the undersigned or to any third party independently of the cause of the same;
6. To take responsibility for accidents to yourself or to third parties or damage to the facilities, to their own or to third parties caused directly or indirectly by conduct not complying with the rules or regulations and to engage in compensation for third parties, conductors of other means and not, and to the management company;
7. To agree to compensate Turismo Lavarone Srl for damages to the ski-lifts, the connected facilities and to the service staff or to any other charges that the you are liable for;
8. To be aware that the operator can at any time withdraw the access ticket to the facilities as a consequence of dangerous and negligent behaviour as a result of non-compliance with the regulations and that no compensation will be due;
9. To recognize the obligation to use specific protective gear common for the discipline before accessing the trails (integral helmet, homologised protection gear, back protector, etc.) and in the knowledge that service personnel may prevent you to access to the Bike Park in the absence of the same;
10. To be aware that service personnel have the power to stop at any time and without notice the transport service and the use of the trails whenever cause of force majeure or meteorological conditions or if the circumstances of the safety conditions impose it. We state also that no compensation or indemnity is due in these cases;
11. To allow the Turismo Lavarone Srl to use my name, images, video or any other representation when using the facilities of Bike Park Lavarone without my specific consent or permission;
12. To agree in the event of a dispute the exclusive jurisdiction of the Forum of Trento (TN)

The undersigned expressly confirms to understand and agree to all of the foregoing and waives any legal and / or extrajudicial actions against Turismo Lavarone Srl and / or its legal representatives, directors, staff members and employees for any damage that has occurred to their person or to your gear, including death, when using the Bike Park Lavarone. I also give my consent for compensation in favour of the operator or any third party involved in the event of a legal and / or extrajudicial action against Tourism Lavarone Srl directly or indirectly due to my own negligent behaviour.

The undersigned states to have carefully read and understood this release of liability agreement prior to signing it, understands its contents and and legal implications and signs as a free act with full knowledge of its significance.
